Research into jury decision making has demonstrated that jurors vote for life because of mitigation including dysfunctional and traumatic childhoods, mental illness, remorse, and poverty. The bulk of this research was performed by the Capital Jury Project (CJP). CJP is a long-term research project that began in 1991 with support from the National Science Foundation. Over the last 25 years, the CJP has conducted 1198 in- depth interviews with jurors from 353 capital trials over 14 states. "[T]he CJP was designed to: (1) systematically describe jurors' exercise of capital sentencing discretion; (2) assess the extent of arbitrariness in jurors' exercise of such discretion; and (3) evaluate the efficacy of capital statutes in controlling such arbitrariness."
